PROGRAM DESCRIPTION

Through in-country experiential learning (and other modes), students will be immersed in the "Recreation, Event, and Tourism industry model." Course destinations, learning activities, and local experts will help teach content while providing a unique chance to experience, firsthand, the innovative aspects of the New Zealand leisure/travel industry and connect academic knowledge to professional practice.

Planned recreational and tourism activities for this program *may* include: surfing, sea kayaking, stand-up paddleboarding, 'black-water rafting' and cave exploration, visiting a geothermal site, experiencing Maori cultural tourism, visiting filming locations such as Hobbiton film, behind the scenes tour at WETA Cave, New Zealand national museum, jet boat ride, Milford Sound tour, and hiking.

LEARNING OBJECTIVES

Upon completion of this course the student should be able to:

- Demonstrate an understanding of the commercial recreation and tourism industries through course assignments and quizzes.
- Apply an understanding of the interrelationships of commercial recreation and tourism (as proposed in the "Recreation, event, and tourism industry model") through course assignments.

- Develop an understanding of the diversity in New Zealand in terms of culture, natural resources, geography, and leisure/tourism opportunities.
- Demonstrate knowledge of the broad array of employment opportunities available in commercial recreation and tourism.
- Discuss challenges related to providing leisure/travel opportunities while minimizing natural resource and cultural disturbances.
- Explain the differences and similarities in the leisure/travel opportunities between the USA and New Zealand.

ELIGIBILITY

Student Eligibility - Program leaders may determine stricter eligibility requirements, but at a minimum, all applicants earning credit in a program would meet these requirements:

- Current WKU student eligible to enroll in WKU courses OR students from outside WKU may participate as non-degree seeking student.
- Good academic standing as defined in the Undergraduate Catalog or Graduate Catalog.
- For those younger than 18 at time of departure: Must be registered in a WKU course for credit, Must be a part of an established WKU program, and no guarantee of acceptance due to different program design and location.
- No current disciplinary sanctions as verified by the WKU Office of Student Conduct:
 - Students who become ineligible to attend the program after applying due to disciplinary sanctions will be subject to standard program cost penalty rates. Students are responsible for notifying the

SAGL when they become aware of this ineligibility. For eligibility questions pertaining to disciplinary sanctions, students should contact the WKU Office of Student Conduct.

- Students must complete [Study Abroad & Global Learning application process](#) prior to being registered in this course.
- Student must possess passport book valid for a least six (6) months after return date.
- Students must complete pre-departure orientations.
- Full payment prior to departure.
- Permission of instructor(s) is required.

If a student completes a program without full payment prior to the departure, the student should receive an incomplete until the obligation is paid. SAGL will inform faculty leaders if a student is in this situation prior to the Study Away term grade deadline.

- Transportation to and from hometown and Nashville Airport (BNA)
- Travel cancellation/interruption insurance. *Highly recommended.*
- Airline baggage fees for overweight or extra bags (Note: our program does not allow students to bring extra luggage)
